4. FIRST AID MEASURES

EYES: Hold eyelids apart, initiate and maintain gentle and continuous irrigation until the patient receives medical care. 5. FIRE FIGHTING MEASURES

SUITABLE EXTINGUISHING MEDIA: Alcohol resistant foam; Carbon Dioxide (CO2); dry chemical; dry sand; use water to keep containers cool.

UNSUITABLE EXTINGUISHING MEDIA: Do not use high pressure water jet as this may spread the area of the fire.

SPECIFIC HAZARDS IN CASE OF FIRE: Releases flammable vapors below normal ambient temperatures. When mixed with air and exposed to ignition source, vapors can burn in open or explode if confined. Flammable vapors may be heavier than air and travel long distances along the ground before igniting and flashing back to vapor source. Move containers from fire area if it can be done without risk. 6. ACCIDENTAL RELEASE MEASURES
